Cancellations received 44-22 days prior to departure will be charged a cancellation fee equivalent to 50% of total trip cost; cancellations received 21-08 days prior to departure will be charged a cancellation fee equivalent to 75% of total trip cost. For cancellations within 07 days of departure and for no shows, no refund will be made. Optional trip cancellation insurance is highly recommended.
