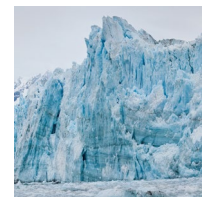

Cancellations received 99-80 days prior to departure will be charged a cancellation fee of 30% per person. Cancellations received 79-64 days prior to departure will be charged a cancellation fee equivalent to 55% of total trip cost; cancellations received 63-34 days prior to departure will be charged a cancellation fee equivalent to 80% of total trip cost. For cancellations within 33 days of departure and for no shows, no refund will be made. Optional trip cancellation insurance is highly recommended and details are available upon request.
