P.P deposit has a \$100. p.p. non-refundable deposit for individual passengers canceling up to 66 days prior to the commencement of Jet Vacations LLC services. Full cancellation: Failing to pay the contractual deposits (other than the initial non-

Should payment not be received within this time limit, the group stay shall be deemed to be canceled by the Customer. In the event of full cancellation of the agreement by the Customer, which is not justified by Jet Vacations LLC's failure to meet its obligations, cancellation penalties shall be invoiced & calculated as follows:

- A service fee of \$100. PP becomes non-refundable.

 Initial partial fee/deposit**: non-refundable up to 95 days prior departure
- From 94 days prior departure to day of departure & No-Show: A 100% penalty of total cost
