Deposit Requirements

Cancellation ~ Deposit is refundable until September 29, 2025. After that point there are no refunds without travel insurance.

Baggage ~ Portage of baggage is included in program; it is based upon a maximum of 1 piece of standard baggage per person plus 1 carry on.

Items Not Included ~ Our tours do not include items of a personal nature such as laundry, room service, laundry, telephone charges or other hotel extras. All passengers are responsible for settling any such costs incurred before checking out of each hotel or returning home.
