Get ready to embark on an exhilarating adventure of a lifetime with Odyssey of the Seas!

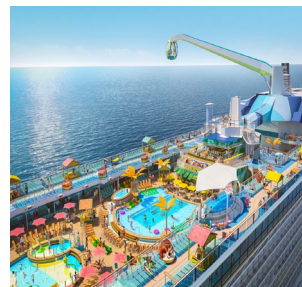

Cancellations received 77-64 days prior to departure will be charged a cancellation fee equivalent to 55% of total trip cost; cancellations received 63-35 days prior to departure will be charged a cancellation fee equivalent to 80% of total trip cost. For cancellations within 34 days of departure and for no shows, no refund will be made. Optional trip cancellation insurance is highly recommended and details are available upon request.
