Day 1 – Mon., June 1 HARRISBURG/CAPE COD D

Depart for Cape Cod with lunch stop (on own) enroute. Extending some 70 miles into the sea, the Cape has natural beauty and quaint colonial villages. Stroll pristine beaches, revel in the arts and culture, and reclaim childhood memories of seashells, sandcastles, and saltwater taffy. Check into the **BAYSIDE RESORT**. **DINNER**

DAY 2 - Tues., June 2 CAPE COD - PROVINCETOWN B, D

BREAKFAST (extended Continental) is served at the hotel this morning.

GUIDED TOUR-Travel historic ROUTE 6A, **Old King's Highway**, a scenic byway winding through centuries of Cape Cod history. Visit CAPE COD NATIONAL SEASHORE VISITOR'S CENTER. Sand dunes and the ocean surround you as you approach "Land's End" – **PROVINCETOWN**. Formerly known as the "Province Lands" the pilgrims landed here first before then settled across the Bay in Plymouth. Enjoy this artists/fishermen village so unique.

CHOICE OF WHALE WATCHING OR DUNE TOUR

***WHALE WATCHING** (3 hours). Travel into the natural habitat of a diverse marine environment including birds and fish which use these shallow waters to feed. Try to spot Humpback, Minke, and Fin Whales. A naturalist will introduce you to everything you see and answer your questions about the whales, birds, fish and lighthouses. **OR CHOOSE:**

* **DUNE TOUR**. Enjoy a one-hour ride along the shoreline of the protected lands of the Cape Cod National Seashore. Your guide will point out the "dune shacks" where famous artists and writers became inspired to create their art.

DINNER

Day 3 -Wed., June 3 CAPE COD - MARTHA'S VINYARD B

BREAKFAST (extended Continental) is included at the hotel.

Meet your **guide** at hotel and Start with a **Highlight Tour of Hyannis** including the **John F. Kennedy Memorial**. Then depart for a **CRUISE** to the "storybook island" of **Martha's Vineyard**. Based here is the Woods Hole Oceanographic Institution (WHOI), a private, non-profit research facility dedicated to the study of Marine science and the education of marine scientists. It is the largest independent oceanographic institution in the world. It was WHOI's research vessel, the Knorr, that found the *HMS Titanic*, off the coast of Newfoundland in 1985. Partake in a "**DOWN ISLAND**" **Tour** including the whaling town of Edgartown and Oak Bluffs, the "Cottage City" with its brightly painted cottages, decorative "gingerbread" houses, the **antique carousel** & celebrity's homes. Depart 5:00 pm. Dinner on own.

DAY 4 - Thurs., June 4 CAPE COD/NEWPORT B, D

BREAKFAST (extended Continental) is included at the hotel. Depart your hotel and travel to town of **NEWPORT**, RHODE ISLAND. Guided Tour of this charming town then free time for lunch and browsing shops and more at Newport Harbor. Next, self-guided tour of the **MARBLE HOUSE**, summer house of Mr. & Mrs. William Vanderbilt. Overnight at the **WYNDHAM HOTEL** Middletown/Newport. **DINNER** in **NEWPORT**

DAY 5 - Fri., June 5 NEWPORT/HOME B

BREAKFAST (extended continental) at hotel. Enjoy a self-guided tour of the **BREAKERS MANSION**, the grandest of Newport's summer "cottages" and a symbol of the Vanderbilt family's social and financial preeminence in turn of the century America. Enjoy a photo-op along the famous coastal walkway, *the Cliff Walk*.

Passenger Cancellation Policies: The \$600.00. P.P deposit has a \$100. p.p. non-refundable deposit for individual passengers canceling up to 90 days prior to the commencement of Jet Vacations LLC services. However, services which have been prepaid by Jet Vacations LLC on behalf of individual clients may be non- refundable, non-exchangeable, non-changeable and/or maybe subject to a cancellation- change fee (e.g. theater tickets, Train tickets, Airline Tickets, Event Tickets, Passes, Entrance fees etc.).

Full cancellation: Failing to pay the contractual deposits (other than the initial non- refundable service fee / deposit) constitutes a cancellation. In the event of non- compliance with the payment due dates, Jet Vacations LLC shall have the right to demand the Customer to immediately pay the outstanding balance. Payment shall then be received by Jet Vacations LLC within eight days as of the date of Jet Vacations LLC's written request. Should payment not be received within this time limit, the group stay shall be deemed to be canceled by the Customer. In the event of full cancellation of the agreement by the Customer, which is not justified by Jet Vacations LLC's failure to meet its obligations, cancellation penalties shall be invoiced & calculated as follows:

- A service fee of \$100. PP becomes non-refundable.
- Initial partial fee/deposit*: non-refundable up to 90 days prior departure.
- From 90-64 days prior to departure, a \$600.00 penalty will apply
- 64-36 days prior departure up to a 75% penalty will apply.
- From 35 days to day of departure & no show: A 100% penalty of total cost per person. Trip cancellation insurance is recommended.

If a passenger cancellation creates a change in the price schedule, the tour price will be revised based on the remaining number of participants. A passenger becoming a single as a result of a partner's cancellation must pay the single supplement unless both have purchased cancellation insurance.

Postponing of a tour by Jet Vacations: As clearly mentioned in our GENERAL PROVISIONS below, Jet Vacations LLC and Tourific Travel, Inc. seek to provide services as published or stated in the final Passenger documents. But conditions, events (as listed below in the RELEASE FROM LIABILITY section but not limited to) may affect travel arrangements, planned tours, cruises, itineraries or any other aspects of the travel experience, making traveling to a location (including but not limited to countries, cities, sites, etc.), tour or cruise routes unsafe for traveling / navigation or in other respects, raise sufficient doubt about safety.
